

MINUTES OF THE MEETING OPENING REMARKS

1. Dr.N.S.Narahari - Chairman - HSS board welcomed all the members. Chairman read the minutes of the meeting of 9thBoS meeting held on 23rd January 2018 in revising the syllabi of the subjects under HSS and briefed about the agenda of the present meeting.

I. Languages

1. Kannada:

Dr.Gayathri Reddy shared the information that the Visveswaraya Technological University (VTU) has included the course on Kannada language as per the directions from the state government and the course has been allocated 2 credits out of the 175 credits for the award of Bachelors of Degree in Engineering. She however mentioned that the Board is free to discuss in the context of the institution and arrive at the decision regarding the course on Kannada language. Some members also contributed the thought of offering to the students a self-paced training on Kannada as an online course through available open source platforms. The Chairman shared the information that in the past the institution has requisitioned the services of two teachers to teach the course on Kannada and that the teachers were great motivators for the students to learn the language for colloquial usage and pondered whether the online system can help the students to get the same level of motivation.

Prof.Vidya, Kannada Faculty Co-coordinator presented brief description of the Kannada syllabus to the members. As per the 2018 scheme, the course will be during the 3rd Semester and 4th Semester. The Students to be grouped in two cycles, as per the practice adapted in the First Year. The members expressed that the course to be given due weightage and opined that the Course must be allocated a maximum of 2 credits. Members felt that the Course content must be focused on administrative Kannada, as per the Government of Karnataka Guidelines and Subsequent orders from Visweswaraya Technological University, Belagavi. Dr.N.K Srinath Dean Academics requested the Faculty in charge to submit a proposal for approval for installation of audio system in the class room identified for the transacting the course on Kannada language.

2. Professional Practice –I (Communicative English)

- Dr. Raju - subject expert, expressed his views that having contact hours for English, in addition to the Online Laboratory based training using the platform provided by M/S Pearson India Limited that has already been implemented by the institution will serve the needs of the learners for faster grasping and better understanding of the nuances of the English Language. The Board appreciated the point and gave an assurance to work towards the same.
- The Members present were of the strong opinion that the English Language Laboratory Courses and the Online training using the Platform provided by the M/S Pearson India Limited must also be extended to the diploma students admitted through the lateral entry quota. This has to be taken up for the students to be admitted during the admission year 2019-2020.

Resolutions:

Kannada: To be introduced during the 3rd Semester and 4th Semester for the students admitted during the year 2018-2019 under the 2018 scheme for Bachelors of engineering degree programs of study. The Curriculum proposed has been approved. Regarding the credit allocation, the Board was of the opinion that at least one credit must be allocated for Kannada. The board felt this was necessary to make the students take this course seriously.

English: Continuing with the Training on English Language Skills using the Online English Platform using the Software Solutions provided by M/s Pearson India Limited and also provides online access to the diploma students admitted under the lateral entry quota. The Curriculum has been approved by the Board.

II. Management Studies:

- Dr. C.Bindu Ashwini briefed about the curriculum proposed by National Entrepreneurship Network under the Wadhvani foundation and also outlined the teaching pedagogy of the online course for the entrepreneurship portion of the course on Intellectual Property rights & entrepreneurship(16HSI51/61) in the academic year 2018 -2019 common to all the programs.. The Foundational course on Entrepreneurship to be introduced as Global elective for VII Semester students in the present academic year 2019-2020 (For the 2016 Scheme of study).
- Dr.Purushotam Bung, suggested that the scheme of evaluation should be project based. He was of the opinion that the course content to be focused on business plan and also the Semester End Examination to be evaluated based on real project based outcomes. He also suggested to have detailed explanation on the evaluation of the students' performance added to the curriculum document.
- Final assessment to be provided by the Wadhvani foundation giving all the details evaluation and also the parameters of awarding the marks.

Resolution:

- The course titled “Foundational Course on Entrepreneurship” to be offered as a Global Elective in the 7th semester of the Bachelors of Engineering degree program of study under the 2016 scheme of study. This shall be implemented during the academic year 2019-2020.

II. Professional Practice II and III for undergraduate program of study.

Dr.C.Bindu Ashwini briefed about the proposed modules and contents of the course titled Professional practice – II and III. The scheme of assessment and evaluation was also discussed in detail. The final CIE marks is obtained by considering the average of Test 1 (Conducted during 3rd Semester) and Test 2 (Conducted during 4th Semester) and final marks on 50 is submitted to CoE by the respective department during the 4th semester. The same scheme of evaluation will be adapted for the 5th & 6th Semester as well.

One of the members Dr.Raju made a suggestion to indicate the prescribed teaching pedagogy in each of the courses offered under the **Humanities & social sciences board of studies**. All the members opined that the unitization of the curriculum under the category of courses titled

Professional Practice starting from the 1st semester onwards will not be meaningful, since most of these are skill based courses. The Deans of Academics & students affairs said that the matter will be decided in the Joint Board of Studies as well as the Academic Council. It was decided to send the proposal of the curriculum for further approval without demarcating the units in the courses pertaining to professional practice.

One of the members Dr.Purushatam Bang suggested that the institution must consider having on rolls a dedicated Training officer in the campus in order to further professionalize the implementation of the training and skill development of the students using the courses titled professional practice for personality development & placement orientation.

Mr. Ramesh Shankaran suggested a book titled “Campus to Corporate” authored by Prof. Joshi of Symbiosis which caters the inputs in enhancing the communication skills of the students.

III. Professional Skill Development for Post Graduate (I M.Tech) of all the programs.

Dr.C.Bindu Ashwini shared the views on Professional Skill Development. In 2016 scheme the course that was being offered for 2 credits and in the 2018 scheme of study. She stated that it mandatory audit course. The Board said that the same may be continued for the ensuing admission batch.as well.

Dr.Raju appreciated and pointed out that the title of the course is well framed and very much apt for the contents given in the prescribed curriculum plan.

Resolutions:

The course on professional skill development to be offered as mandatory audit course in the I semester to the students pursuing Master of Technology degree (common to all the programs of studies).

IV. Proposal to introduce Foreign Language for the students of UG and PG programs.

- Dr.C.Bindu Ashwini suggested that German language to be offered as a proficiency course and also mentioned that Dr.Nataraj, Associate Professor, Department of Mechanical Engineering as a resource person to initiate the course.

Resolutions:

- German language to be offered as proficiency course during the months of June/July -2019 as a pilot initiative.



MINUTES OF THE MEETING **OPENING REMARKS**

Dr.Rajeswara Rao - member of HSS board welcomed all the members. Dr.C.Bindu Ashwini, convenor of HSS board read the minutes of the meeting of 10thBoS meeting held on 22nd May 2019 in revising the syllabi of the course under HSS and briefed about the agenda of the present meeting.

Languages **Kannada:**

- Prof.Vidya, Kannada Faculty Co-coordinator presented brief description of the Kannada syllabus to the members. As per the 2018 scheme, the course was in the 3rd Semester to all the programs. The Students to be grouped in two cycles, as per the practice adapted in the First Year. Dean Academics Dr.ShanmukhaNagaraj expressed some of his observations in making the Teaching – Learning process more effective.
 - a. The internal evaluation process to be focussed on the Kannada culture – field visit to Mysore Palace, Hampi etc.
 - b. Emphasize on Kannada heritage as an experiential learning. Report on field visit to be given a weightage of 10 marks.
 - c. Only one CIE to be in the form of a written test and CIE –II to be experiential learning on the field visit, after which the students are asked to prepare a report, and a weightage of 10 Marks to allotted for the report.
 - d. Adding to the Dean Academics observations, the external experts also expressed that the field visit evaluation could be done in the form of narration/story telling/ presentation/ one to one interview amongst the students in Kannada, reading newspapers, to enhance the communication skills of the students.
 - e. Dr.Raju suggested that in order to improve the fluency in Kannada one of the software “Tantra Jnana dalli Kannada balake” will be useful for the students to understand and learn in a broader spectrum.

- f. The CIE – II to be reframed in a form of self – study. The interested faculty from each department to be identified and seek their support in assessment and evaluation process.

English

- Dr. Raju - subject expert, expressed his views that in the module Listening and Speaking more importance on the Phonetics is very much essential in order to improve the articulation. Phonology will cater in improvising intonations and interpolations and also to enhance intelligibility – refers to clarity in speech.
- Principal suggested continuing online course in English for the upcoming academic plan. There is no change in the existing methodology in conduction of English class.

Resolutions:

Kannada: To be continued the 3rd Semester. The board felt that field visit to heritage places is essential

English: Continuing with the Training on English Language Skills using the Online English Platform using the Software Solutions.

III. Management Studies:

- Dr.RajeswaraRao briefed about the content of the course titled “Foundations of Management and Economics” and also mentioned that in the 2016 scheme the course was offered for 2 credits and now in the 2018 scheme it is offered for 3 credits.
- Dr.Purushotam Bung suggested the change in the course title as “Introduction of Management and Economics”. RVIM would also volunteer in sharing their expertise by delivering expert talks and also reviewing the course contents of Economics. Prof.Purushottam suggested have the title as Introduction to Management and Economics.Dean Academics informed the board that it can be done.so, we can say that it has been resolved to change it to “Introduction to Management and Economics” and not “Introduction of Management and Economics”.
- Dr. C.Bindu Ashwini briefed about the curriculum proposed by National Entrepreneurship Network under the Wadhvani foundation and also outlined the teaching pedagogy of the online course for the entrepreneurship portion of the course on Intellectual Property rights & entrepreneurship carried out in the academic year 2019 -2020 common to all the programs. The IPR content is handled by the faculty of RVCE and the content of the Entrepreneurship is provided online, students are supposed to go through the activity and the same will be discussed/monitored in the class by the RVCE faculty.
- Dr.Chitra presented the syllabus to be approved for the upcoming V/VI Semester under 2018 scheme offered for 3 credits in the academic year 2020-2021.
- Dr.Purushotam Bung suggested that the content in the syllabus to be reframed since the topic on Design Thinking/Industrial design – Unit-III will be repetition, not to be included in IPR, as the students will be studying in their professional courses. The IPR& E to be in a form of workshop based learning.
- Principal suggested to offer a course titled “Managerial Economics” in the V Semester as a global elective. The daft of the syllabus will be prepared by the RVCE faculty and the review of the same will be done by Dr. Purushotam Bung. He also volunteered to provide the expert talk. Principal initially said the course title as managerial Economics and later it was decided to title the course as **Engineering Economics**. The syllabus for the same will be drafted by Dr. Shobha

N S of IEM. Once the syllabus is approved then it can be resolved to introduce the same as Global Elective from HSS board during V semester. The board principally agreed for the same.

- The course titled “Constitution of India and Legal studies” will be the agenda to be discussed in the next HSS board meeting.

V. Professional Practice II and III for undergraduate program of study.

- Dr.C.Bindu Ashwini briefed about the existing modules and contents of the course titled Professional practice – I and II. The scheme of assessment and evaluation was also discussed in detail. The final CIE and SEE marks is obtained by considering the average of Test 1 (Conducted during 3rd / V Semester) and Test 2 (Conducted during 4th / VI Semester) and final marks on 50 is submitted to CoE by the respective department during at the end of II/III year respectively.
- Principal expressed his observation regarding the students participation in the training program is very low. To improvise the students participation the training sessions to be more effective/innovative way of making understand the modules/group exercises which makes the students to develop interest to participate in the training sessions.
- He suggested developing a questionnaire in order to determine the interest and the student’s requirement in the training program will also give us an idea to restructure the training program.
- Dr. Purushotham Bung also suggested that if the training is in the mode of participatory learning then the modules could be delivered in a very effective way.
- Dr.Uma B.V. Dean Student Affairs suggested having evaluation process of PP-I and PP- II in the form of mock GD/ Interview and written test on Aptitude skills which makes the students more focussed in the training program. The rubrics to be framed for the evaluation process.

Sub No. 53: Proposal for introducing Liberal Arts course as professional elective to be offered through HSS.

Dr.C.Bindu Ashwini read the list of courses offered under Liberal Arts. The below mentioned list of courses were proposed by the members in the board.

Sub No 54: Discussion on the AICTE mandated course titled “Universal Human Values 2: Understanding harmony” as per the structure given by AICTE to be offered in 3rd and 4th Semester level during the academic year 2020-2021.

- Dr.Raju suggested that the course can be introduced as an audit course and made more interactive session on Human values by organising sessions with the experts from Ramakrishna Ashrama.
- Principal suggested that the course topics can be included in induction program and make students to participate actively which will cater their activity points.

OPENING REMARKS

- Dr.N.S.Narahari – Chairman – HSS Board welcomed all the members. Dr.C.Bindu Ashwini, convenor of HSS board read the agenda of the meeting. Dean Academics – Dr. Shanmukha Nagaraj – read the circular received from the VTU regarding the implementation of Kannada language as 1 credit for III Sem students of all the program from the academic year 2020-2021.
- Dr.K.N. Subramanya – Principal shared the information about distribution of credits, that the **Kannada language to be offered for 1 credit under 2018 scheme**. The present 2018 scheme students of III Semester will be having 16 credits in the VIII Semester, of which, now in that 18 credits, 1 credit to be allocated to Kannada in the III Semester, and in the VIII Sem they will be having 15 credits. Dean Academics was also informed to incorporate the changes in the present third semester syllabus and scheme.

The course book is provided by the VTU and the syllabus is also available. The course content will be made available in the VTU website in the first week of September as per the circular received from VTU.
- Principal suggested that total number of hours is 16hrs in a semester. 1hr/week. As per the VTU circular the students to be grouped into 2 categories – **Vyavaharika Kannada i.e Balake Kannada – for the non – Kannadiga students and Adalitha Kannada for the Kannadiga students**. He also

suggested that the teaching to be in the mode of visualisation rather than only lecture or power point presentation. The course materials to be securitised thoroughly. He also suggested that the students of Kannada Sangha to be involved in the activity and also in the preparation of videos/ppts.and any other course materials as per the syllabus.

- Dean Academics suggested that the course outcomes to be prepared in the Kannada only.
- Dr.Raju suggested the change in the title of the course, abut as the title of the course was already prescribed by the VTU hence it is agreed by the board of the members to retain the same.
- Principal suggested evaluation process to be done separately for Balake Kannada and Adalitha Kannada.

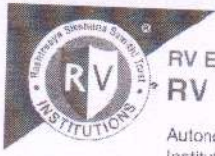

KANNADA COURSE REPORT -2021

As per the VTU circular (Ref: VTU/Aca/A-9/2020-21/2110) dated 4th September 2020, Kannada language to be considered as compulsory credit course to students of second year Engineering from 2020-21 onwards and the course was evaluated considering both CIE and SEE. In this regard, Kannada course is offered to all programmes of B.E., from HSS Board of RVCE.

Faculty taught Kannada are:

1. Mr. Srinivasa Prasad. H. G
2. Smt. Lakshmi R. K
3. Dr. Suma Sanjeev
4. Smt. Vanishree. S

Due to pandemic disease Kannada classes were conducted in online mode and classes were scheduled from October 19th 2020 and up to January 21st 2021. The students were grouped into 2 categories – Vyavaharika Kannada i.e. Balake Kannada – for the non – Kannadiga students and Adalitha Kannada i.e. Sanskritika Kannada for the Kannadiga students. Two separate sets of syllabus were prepared and also 2 sets of question papers were prepared.

1. VyavaharikaKannada(18HS38V)
2. Aadalitha Kannada (18HS38A)

Teaching Hours:16hrs and 1hr/week.

The preparation of videos/ppts were prepared by faculty to teach the syllabus.

Scheme of Evaluation – CIE and SEE

For Vyavaharika Kannada (18HS38V)

CIE is executed by way of quizzes (Q), tests (T) and Activity. A minimum of two quizzes are conducted and each quiz is evaluated for 10 marks and the sum of the marks scored from two quizzes is reduced to 10. The two tests are conducted for 50 marks each and the sum of the marks scored from two tests is reduced to 30. The marks component for Activity is 10. Total CIE is 10(Q) +30(T) +10(A) = 50 Marks.

Semester End Evaluation (SEE); Theory (50 Marks)

SEE for 50 marks is executed by means of an examination. The Question paper for the course contains two parts, Part – A and Part – B. Part – A consists of only objective type questions for 40 marks covering the complete syllabus. Part – B consists of essay type questions for 10 marks.

For Aadalitha Kannada Course (18HS38A)

SEE for 50 marks is executed by means of an examination. The Question paper for the course contains two parts, Part – A and Part – B. Part – A consists of objective type questions for 10 marks covering the complete syllabus. Part – B is for 40 marks. It consists of simple grammar and essay type questions.

Sub No. 63 Approval for syllabus of curriculum of course on Constitution of India and Professional Ethics – 18HS71 offered for 3 credits in the 2018 scheme to all the Undergraduate B.E programs offered in 7th Semester during the Academic year 2021.

- The syllabus was already shared to all the members through email 2 months back in the midst of the pandemic. Dr.B.T Chitra presented the syllabus to the members. The topics included in this have been approved unanimously by all the members. The course is offered for 3 credits. The focus is given on Indian Penal code as a new topic in the syllabus as was suggested by one of the board member through email communication.

Sub No. 64 Implementation of HSS&LE curriculum in line with NEP 2020 as per the guidelines of the VTU for the academic year 2021-2022.

I Year B.E Under graduate programs: Courses on Technical English - I and II (1st and 2nd Semester) and Universal Human Values – II.

- The course Technical English is offered for 1 credit each in I and II Semester as per the VTU guidelines – Dr.C.Bindu Ashwini- English – Faculty Co-ordinator briefed about the English online classes and the conduction of CIE and SEE for the previous year and also expressed that the McGraw Hill is given a good service and the students also feel that the contents in the online course is not elementary,. The quality in the content is good.
- The Universal Human Values – I is covered in the induction program and it is mandatory.Universal Human Values – II is to be covered in the II Year i.e. in the 4th Semester.
- Dean Student Affairs expressed that, as per the AICTE notification students who have covered HSS courses in their lower classes will be offered for 2 credits in the Engineering program or else it is to be offered for 3 credits if the student has not studied Human values related courses.
- There are two new courses to be introduced in the first year for B.E students of all the programs for the academic year 2021-2022.
 - a. The course titled Indian Knowledge System (IKS) will be offered for 1 credit for the one cycle. (Physics/Chemistry). The outline of the curriculum for this course was presented to the board members. The detailed syllabus will be prepared and circulated among all the members at a later point in time.
 - b. Yoga and Practice will be offered for 1 credit for another cycle in the first semester. In the second semester the courses are swapped between the cycles.(Chemistry/Physics)
- Dr.Shireesha, presented the syllabus of Yoga and practice to the members. Dr.Purushotam Bung, who is also a Yoga practitioner from Ministry of AYUSH, suggested to follow “Common Yoga protocol”. The syllabus of Yoga and Practice to be framed in reference with AYUSH protocol. The course to be delivered by the yoga practitioner/ trained yoga as resource persons. The certificate from AYUSH and trained/practitioner from AYUSH adds more weightage to the course. The Master degree in Yoga can also be a resource person for the course to deliver effectively.

- Dr.N.S.Narahari, suggested having a pictorial representation in the lesson plan, if permissible in consultation with the Principal.

- Intellectual Property Right (IPR) as** a compulsory course (5th Semester) to be offered in the 5th semester. The syllabus will be prepared by Dr.Chitra B.T. and will be presented in the next meeting for approval.
- A course on Management and Entrepreneurship (Program specific)the syllabus will be prepared by Dr.Rajeswararao. and will be presented in the next meeting for approval.
- Proposed list of courses to be offered as Electives in V and VI Semester. - The list of courses was discussed with the members. Sports engineering is the one of the course proposed as an elective.
- Several courses such as technical arts, Literature, music, physical education and sports will be introduced and offered as electives to the students. The list is given by both AICTE and VTU.

Sub No 65 Implementation of 21st Century Skills to enhance the Professional Skill Development in II Year and III Year Undergraduate programs.

- Modules from DalhamLearning solutions have been introduced for II year and III year BE students in the academic year 2020-2021. A survey was carried out in the college to find different ways of experiential learning. 18 methods are involved in the hierarchical collective and distributed individuals.
 - The survey analytics on experiential learning includes the topics on industrial problem solving/debate/group discussion/writing journal paper/paper presentation in the conference/virtual experiment developments/sectoral studies in respective courses/poster presentation/product development and open ended experiments/industrial tours. These methods are to be adopted for a better learning
 - In the internal marks 40% of weightage is given for experiential learning and these methods to be adopted for better learning. Liberal arts to be focussed on the integration of science and technology through experiential learning.
 - In the NEP these methods are to be rigorously applied to enhance and strengthen the HSS and liberal education components.

MINUTES OF THE MEETING

OPENING REMARKS

Dr.C.Bindu Ashwini and Dr.N.S.Narahari – Chairman – HSS Board welcomed all the members of HSS board read the agenda of the meeting. The agenda was explained in detail to all the members and also the importance of the guidelines given by AICTE and VTU. The minutes of the meeting and the action taken report was also read out to the members. The action taken report was also read out to the members. The minutes of the previous meeting and the action taken report was unanimously approved by all the members present.

Address by the Principal: K.N. Subramanya

- Dr.K.N. Subramanya – Principal, briefed about the implementation of NEP 2020 policy as per the guidelines given by the VTU Effective from the academic year 2021-2022. The VTU credit distribution structure was appraised to the members. The emphasis on the outcome based education was also emphasised.
- The 2021 scheme of study has been designed drawing inspiration from the NEP 2020 policy guidelines. The proposed changes in the scheme were highlighted pertaining to the courses to be offered under HSS board. The total credits is 160 credits, out of which a total of 12 credits is allocated for the HSS core course in the curriculum. The professional elective courses will further add to the credits weightage.
- The Ability Enhancement courses as per the guidelines of the VTU focussing on the area of liberal education is imperative.
- The minor and major projects is also part of the structure and carried out during the engineering program of study.
- The curriculum and the courses offered were briefly explained pertaining to the 2nd, 3rd and 4th year levels of the proposed curriculum design for 2021-2022 Admission batch.

- There are around 30 activity clubs in the institution. The ability enhancement course is designed in such a way that the students may opt NCC/NSS/performing arts as such, may be offered in the curriculum assigning 1 credit. So that it is benefitting the students and also acts as motivation to take up curricular and extracurricular activities.
- These courses will be categorised as laboratory courses/practical sessions. The assessment to be carried in a different way, not having quizzes/tests.
- The evaluation can also be in the mode of experiential learning, and also providing the practical application in the courses offered.
- Universal human values – around 300 faculty members in the institution has undergone the FDP and are eligible to handle the sessions. The course to be implemented in the IV semester.
- Integration of liberal arts in the engineering technology is very important. There are 1200 courses that have been identified globally as part of Humanities, Social sciences & liberal education. The board can consider courses best suited for the engineering curriculum and offer the same. More emphasis is on liberal education in the policy document of NEP 2020.



MINUTES OF THE MEETING OPENING REMARKS

Dr. K.N. Subramanya, Principal of RV College of Engineering welcomed all the members of the HSS board and read out the agenda for the meeting. The agenda was explained in detail to all the members and also the importance of the guidelines given by AICTE and VTU was emphasized. The minutes of the previous board meeting and the action taken report were also read out to the members. The minutes of the previous meeting and the action taken report were unanimously approved by all the members present.

Sub. No 77: Review of the Minutes of the meeting held on 10.12.2022 in online mode and Action taken report on the minutes of the 15th BoS meeting.

The following points were given more focus.

1. Briefed about the 2022 scheme prescribed by the VTU. Highlighted the comparison between the 2021 and 2022 scheme. The credits are the same in both schemes. English is offered for 2 credits in the first year B.E program and **Balake Kannada** is offered for 1 credit in I year B.E program.
2. Indian constitution is offered for 1 credit in the 1st year B.E program.

Sub. No 78: 2022 Scheme: Implementation of the course in the I year B.E undergraduate programs under the 2022 scheme in the I and II Semester.

1. **Communicative English 22HSE16/26 – 1 Credit** each in 1st Semester and 2nd Semester
Principal briefed about the implementation of STEP (Standard test for English Proficiency) – The Hindu group for communicative English in the academic year 2022-2023.
2. **Fundamental of Indian Constitution -22HSI17** – 1 Credit – the course is focussed more on the electoral aspects.
3. **Kannada –Balake Kannada/Samskrutika Kannada – 22HSBK17/22HSSK17- 1** Credit- The course was well received by the students.
3. **Scientific Foundation of Heath-Yoga (22HSY18/28)** - 1 Credit- the expertise drawn from SPYSS for the conduction of the class and also they are engaged as examiners.

Sub No: 79: Courses in 2021 Scheme: Implementation of the courses offered for 1 credit under the 2021 scheme to all the Undergraduate B.E programs for the academic year 2023-2024.

II Year B.E Undergraduate programs: I Year B.E Undergraduate Programs:

III Semester – Aadalitha Kannada (21HS38A/Vyavarika Kannada 21HS38V (3rd and 4th Semester) for 1 credit as prescribed by VTU – The design and execution of the course will follow the same pattern as in the previous year

Ability Enhancement course – I – 21HS39- 1 Credit – The courses include NCC/NSS/Physical Education/Art and Painting /Theatre Drama/Music/Dance/Photography and Film making. Dean Academics briefed about the conduction of the classes. The student's preferences for the course were taken through Google registration for each of the courses. The CIE and SEE were also conducted in practical mode. The performance-based evaluation was carried out.

4th Semester- Universal Human Values and Professional Ethics- 21HSS48- 2 credits. - Emphasised that the faculty members have undergone the UHV FDP organized by the

AICTE and they are competent to handle the UHV sessions for students of their respective departments. The course has commenced in the ongoing semester.

III Year B.E Undergraduate programs:

V/VI Semester - Mandatory courses

- g. **Intellectual Property Right and Entrepreneurship (IPRE)** as a compulsory course – **21HSI51/61**- Dr.Bung suggested not to include Design thinking in the IPRE.
- h. **Foundations of Management and Economics - 21HEM51/61** – Dr.Bung suggested making changes to the syllabus. The topics on functions of management are to be done in detail. Topics on Organisational behaviour to be included in the management, reduce the theories of motivation instead to focus more on the area of Organisational behaviour. In the Economics part, more focus on microeconomic indicators – GDP, Real growth, inflation, Keynesian model, Classical and Neo-classical model, AS-AD model, and National Budgeting to be done in detail. The NPTEL course on “Do your Venture” is to be suggested to the students for experiential learning.

V Semester -Global Elective: Engineering Economy – to be offered. The suggestion was made to offer a course on the Indian Management System as a global elective.

Course on Entrepreneurship – Foundational course and advanced course in association with NEN to be offered. Dr.Bung suggested mandating the internship exclusively on Entrepreneurship.

VI Semester -Global Elective: **Applied Psychology for Engineers** – to be offered.

IV Year B.E Undergraduate programs

Ability Enhancement Course – II –Proposed courses as Electives–

Cognitive Psychology/International Studies/Business/Foreign Language/Essentials in Economics/Sociology/Anthropology/Liberal Arts/Travel and Tourism Management.

The above-mentioned Ability Enhancement courses are the courses to be proposed in the forthcoming academic years. The introduction of new courses is based on suggestions & initiatives proposed by the members of the present board. The members were briefed about the courses proposed to be offered by the HSS board. The discussion will be taken up in the next BoS meeting.

Sub No: 80: Ratification of the Board of Examiners for the courses offered under Humanities and Social Sciences in the academic year 2022-2023. The list of examiners was presented to the members.

Sub No: 81: Post Graduate Programs: 2022 Scheme

- c. Implementation of the course “Professional Skill Development- I”. Offered for 2 credits in the I year P.G – II Semester common to all the programs. The inputs from the departments are compiled and the modules are framed focusing on the placement aspect. The class is conducted on every 2nd and 4th working Saturday throughout the semester. The training agency is entrusted with the responsibility for the conduction of the class and also the assessment.
- d. Introduction of the online courses through the NPTEL platform offered as elective courses for 2 credits in the II-year PG program.
The courses are shortlisted from the NPTEL portal. Dr. C. Bindu Ashwini presented the list of courses offered by NPTEL. The members agreed to the new initiative. The students are instructed
